Kerala Financial Corporation invites application to three posts of Internal Auditors on contract basis for a period of one year. Details are given below:

1. **Qualification.** Retired KFC employees in the rank of **AGM & above**, age not exceeding **62 years** as on 29.06.2018 and shall be well versed with the operations of the Corporation.
2. **Application Form.** The applicants should apply in the format given as **Annexure 'A'** to the notification. The application forms should be sent by **registered post/speed post** to **"The General Manager, Head Office, Kerala Financial Corporation, Vellayambalam, Trivandrum -695033, Kerala"**, **super scribing name of the post on the envelop**. The application should be complete in all aspects. Incomplete and ineligible applications will be **summarily rejected**.
3. **Last date of receipt of application.** The last date of receipt of application at KFC will be **13.07.2018, 5 PM**. Applications **received after the last date will be summarily rejected without any notice to the applicant**. The applicants working in Govt and PSUs should apply through proper channel.
4. **Selection procedure.** The selection will be done through an interview conducted by the Selection Committee constituted for the same.
5. **Date of Interview.** The interview will be held on 25 Jul 2018 at 10 AM at Head Office, Kerala Financial Corporation, Vellayambalam, Trivandrum. **No further notice will be served to the applicants to appear before the Selection Committee. The applied candidates, having the qualifications specified in Para 1 above, shall report for the interview with proof of age and qualifications. In case of change of date of interview, the same will be intimated through email. No TA/DA will be paid for the interview.**
6. **Selection.** The rank list will be prepared based on marks of interview conducted by the Selection Committee and the list of selected candidates will be published in KFC website [www.kfc.org](http://www.kfc.org). Selected candidates will be given offer letter for the appointment as Internal Auditor of KFC on **contact basis for a period of one year** from the date of joining after executing agreement.
7. **Number of posts** – 03(Three).

8. **Remuneration.** Consolidated pay of **Rs.40000.00** per month.
9. **Place of work.** The place of work shall be at any of the branch offices of the Corporation as decided by the Management of KFC.
