Micro Finance

Self Help Groups (SHGs) are financed between Rs 10 lakhs and Rs 500 lakhs at attractive rates through Micro Financial Institutions (M F Is), which are incorporated as Co-operative Societies, Trusts, Companies, Non Banking Finance Companies, for a period of four years.

Credit Guarantee Fund Trust Scheme for MSE s

Credit facilities up to Rs.50 lakhs, per eligible borrower, is provided on the strength of the industrial security only.

Special Package to N R Ks

Non Resident Keralites who have returned home jobless due to the economic recession on or after 01/07/2007 are given finance up to Rs 100 lakhs at 9% p.a. Applications received till 31.03 2012 will be considered under this special package.

Special Package for Women Entrepreneur & SC/ ST Entrepreneurs

Enterprises fully owned and administered by woman entrepreneur or SC & ST entrepreneurs are eligible for an interest reduction of 1% in any of the eligible activities, subject to a ceiling of Rs 50 lakhs.



Disbursement done on pro rate basis inproportion to the promoters contribution and commensurating with the progress of the project.

Scheme for Energy Saving Projects

In view of the growing need for energy saving and importance of energy conservation, the Corporation has formulated a special scheme to promote energy saving measures in SMEs by providing financial assistance for the implementation of Energy Saving Devices/projects. As per the scheme Energy Management Centre (EMC) has to recommend the proposals for consideration. The effective interest rate under the scheme is kept at 5% p.a. and no processing fee will be charged. An upper loan limit of Rs. 200 lakh has been fixed for such support.

Assistance to Micro Enterprises

The Corporation supports Micro Enterprises mainly to help the first generation enterprises with concessional rates of interest of 7%. The upper limit for finance is Rs. 25 lakhs.

Credit delivery in Cluster

The MSME sector in Kerala is highly diversified in terms of industry segments and geographical terrain. A large segment of MSMEs operate in clusters which have developed at certain different geographical locations due to various factors like historical availability of certain skill craftsmanship in the location, proximity to raw material or customer, etc. MSMEs located in clusters have similar characteristics and face similar challenges. Corporation's credit linked interventions involve providing financial assistance to MSME units in clusters through special dispensations using customised products and processes keeping in view their needs and requirements.
